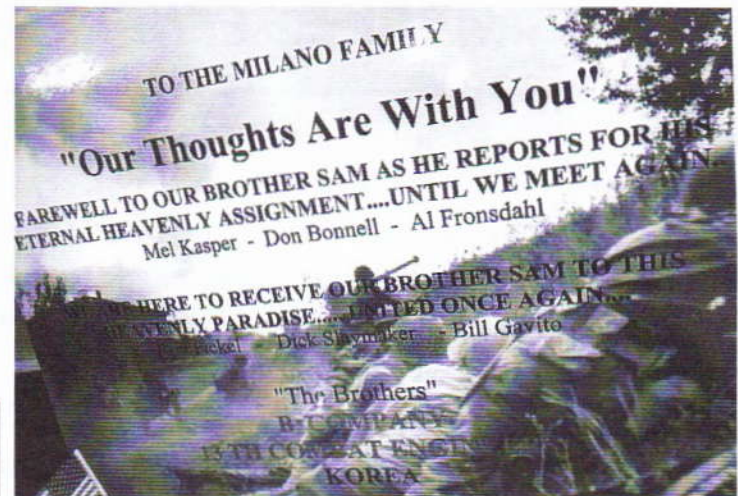

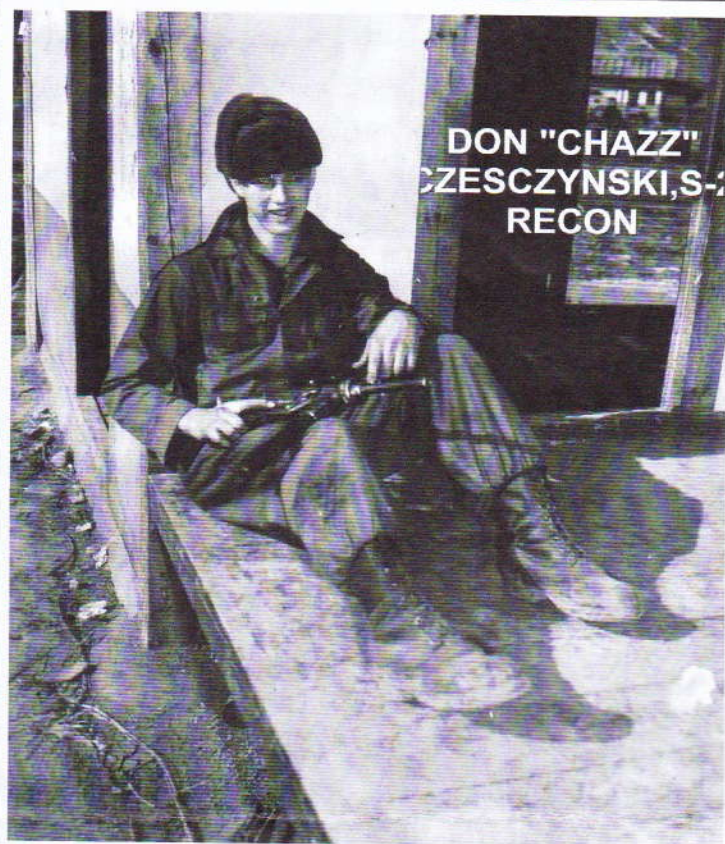

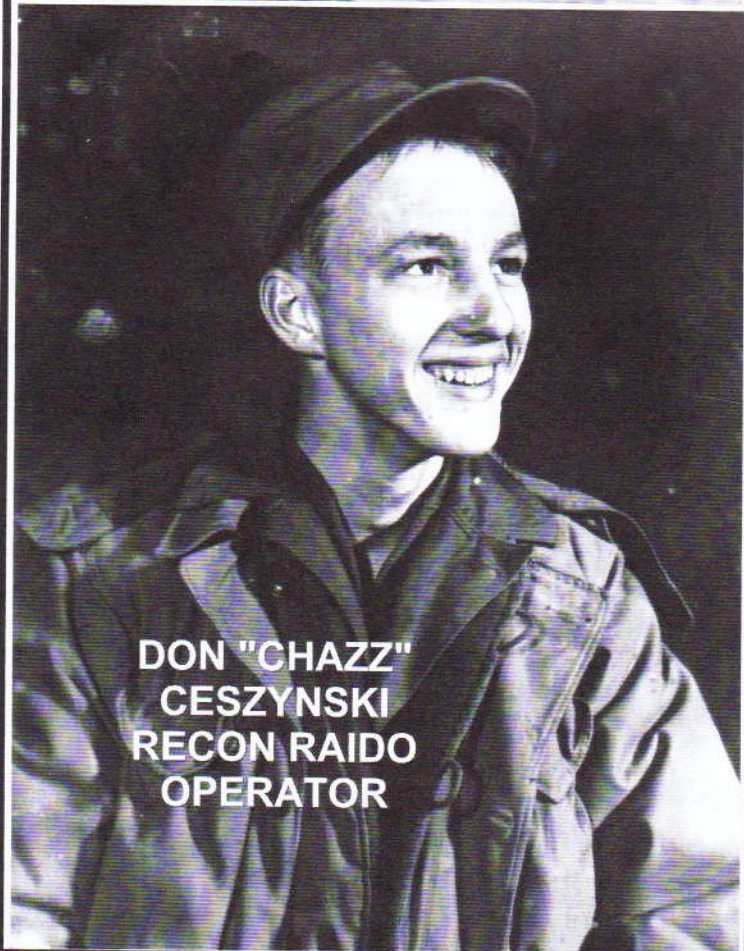

Maurice Henry Reeves

January 8, 2017

Maurice Henry Reeves went home to be with his Lord on Sunday, January 8, 2017. He lived a life filled with faith, family, work and service to his country and fellow man. Maurice was born on May 23, 1919 in Conway, Arkansas and grew up on a farm during the depression. He went to work in the C.C.C. to help his family financially before joining the Army in 1940. He served five years in WWII and one year in the Korean Conflict, as well as six years in the Army Reserve. He served in the 13th Combat Engineers Battalion, 7th Infantry Division and rose to the rank of Master Sergeant. Mr. Reeves was co-founder of the 13th Engineers Battalion Veterans Association. He served on the Board of Governors for many years, as well as President for four years. In 1995, Maurice was invited, along with other veterans, to represent the U.S. Army in the 50th year commemoration of the end of WWII. They traveled to Okinawa and Leyte to participate in memorial services.

Maurice worked for the U.S. Post Office for 30 years. Until recently, he was an active member of Immanuel Baptist Church, teaching a men's Sunday School class and serving as a deacon. Maurice was also active in Gideons International for many years distributing Bibles and serving in their prison ministry. His hobbies included duck hunting, golf, photography and attending Razorback games.

He leaves to cherish his memory his wife of 71 years, Mildred L. Reeves; his daughter, Karen Jones (Bob); his granddaughters, Michelle Hayden (Jon), Suzanne Vest (Craig), and Katherine Ryan (Aaron); brothers, Jake Reeves, John Reeves and Charles Reeves; and sisters, Mary Bailey Cook, Hazel Rhea, Jean Paul and Binnie Shepard. Maurice also leaves behind eight beloved great-grandchildren and many nieces and nephews whom he also loved.

He was preceded in death by his parents, Tom G. Reeves and Agnes Byrne Reeves, stepmother, Joyce Reeves, brother, Howard Reeves and sisters, Margaret O'Brien, Helen Denosky and Barbara Simpson.

THE SOUTH KOREAN AMBASSADOR FOR PEACE MEDAL

NEW APPLICATION FORM

If you are a Korean War veteran, you may be eligible for the Korean Ambassador Peace Medal. The medal is an expression of appreciation from the Korean government to US service men and women who served in the Korean conflict.

To be eligible, the veterans must have served in country during the Korean War from June 25, 1950 to July 27, 1953. It is also available for the veterans who have participated in UN peacekeeping operations until the end of 1955.

If a veteran was a Navy service member and had served aboard a naval vessel, then he or she is eligible if the naval vessel was assigned into Korean waters during the 1950 to 1953 time frame.

Please note that both men and women are eligible for this medal. The military had support positions such as nurse, clerical and administrative, and other positions that were predominantly held by women service members.

Criteria:

1. To establish eligibility, you need a copy of your DD 214. The DD 214 need not be certified or notarized, but it should be legible.

2. There are no costs or fees to the family or to the veteran. There are no legal agreements that need to be met, nor any documents to be signed. This is an appreciation in the form of the Korean Ambassador for Peace Medal from the Republic of South Korea for the sacrifices, service and friendship of our American service men and women who served in the Korean War.

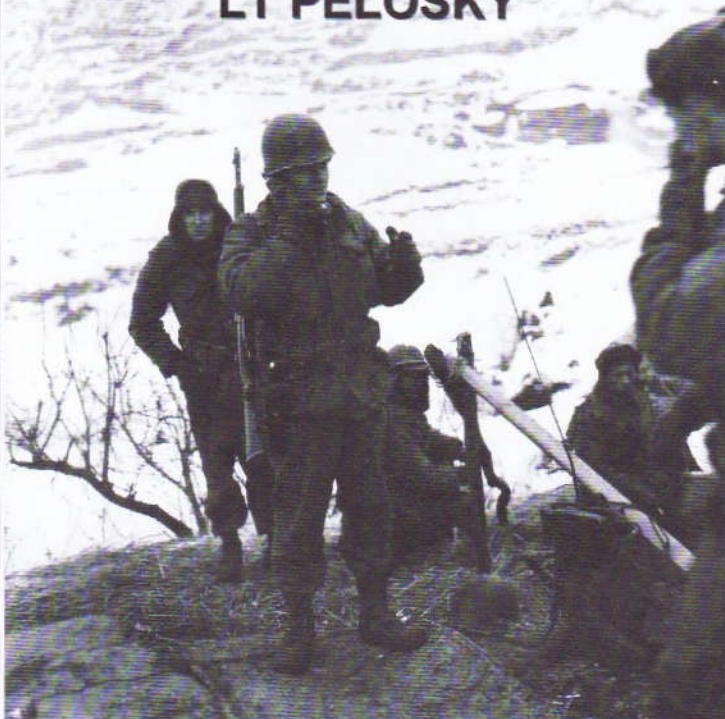
VETERAN OF THE YEAR

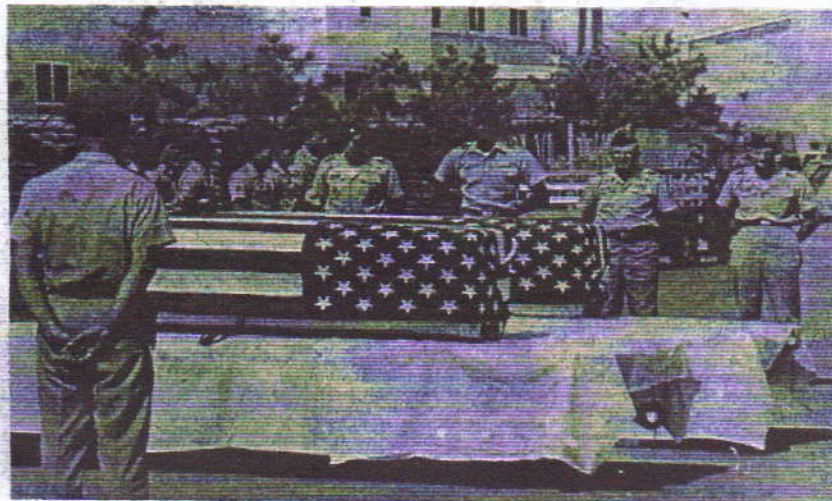


M-1 USED TO DRILL HOLES

Last Rites Given To Slain GI's

CAMP CASEY—As the chaplain ended his remarks, the honor guard snapped to present arms, and a firing squad fired three volleys. As spent brass from the final volley tinkled on the pavement, the solemn notes of "Taps" concluded a plane-side ceremony for two American soldiers who died September 7 while on patrol along the demilitarized zone of the Republic of Korea.

The two soldiers being honored, Privates First Class Joe N. Porter Jr., 21, and Warren Thomas, 20, both from Montgomery Ala., had been assigned to Company C, 1st Bn., 31st Inf., 7th Inf. Div.

The two privates first class were members of a security patrol operating near the Demilitarized Zone (DMZ). Their unit is operationally attached to the 2nd U.S. Infantry Division guarding a section of the eighteen and one-half mile U.S. sector.

Both men lived on the same street in Montgomery and came in the Army at the same time. Pfc. Porter, who arrived at the unit in February was a squad leader. Pfc. Thomas arrived in March and was a rifleman in the company.

Palbearers for the two flag-draped caskets were the two men's friends and comrades from Company C.

Chaplain (Cpt) Cyril J. Vrablic of the 3rd Bde., 7th Inf. Div., gave the eulogy.

Present for the ceremony at Kimpoo Air Field were Maj. Gen. O. A. Leahy, commanding general, 7th Inf. Div.; Col. John H. Cochran Jr., commanding officer, 3rd Bde., 2nd Inf. Div.; Lt. Col. William M. Cole, commanding officer, 1st Bn., 31st Inf., 7th Inf. Div.; Lt. Col. H.V. Ellis, assistant chief of staff, 2nd Inf. Div.; and 1st John K. D. Heilinger, commanding officer, Company C, 1st Bn., 31st Inf.

CAMP IRA — Judith Ann Ford of Illinois may have been chosen Miss America 1969 by the judges at Atlantic City, but the men of the 13th Engineer Bn., 7th Infantry Division have selected Jane Kathryn Bair of Kansas as their Miss America.

7,777 Days in Korea

September 25, 1968

Bayonet Division—7,777 Days in ROK

September 25, 1968, is the 7th Inf. Division's 7777th day in Korea. To commemorate this historic event, Maj. Gen. O.A. Leahy, commanding general, has proclaimed September 25th "7,777 days."

In the proclamation, he said, "Soldiers of the Seventh Infantry Division have earned fifteen Medals of Honor, fifteen Battle Streamers, and two foreign Presidential Unit Citations. During World War II the Bayonet Division fought and traveled 16,910 miles which was further than any other Division in the history of the United States Army. During the Korean War, the Division was the only Division to fight its way to the Yalu River, and the Manchurian border. The bravery and valor of the men of the Division won it the highly coveted title of the 'Bayonet Division.'"

"Today, on our 7,777th day in Korea, we stand realistically ready to defend the freedom which we inherited from our predecessors. As we take pride in our past, we also rededicate ourselves to our mission on Freedom's Frontier. We are 'In War Invincible, in Peace Prepared.'"

Reveille will be held at 7 a.m. on this day of celebration throughout the Division, and all NCO and EM clubs will have happy hours beginning at 7 P.M.

The Post Exchange will celebrate this day by having a 7777 day sale at the Admin., Beavers

and Kaiser P.X.s. \$2,000 worth of merchandise will go on sale at these exchanges, and will incorporate the number "7" in their sale prices. All division P.X.s. will be redecorated to commemorate this day.

At the 7th Division golf course, anyone who shoots a 77 for 18 holes will be given a free round at the course.

The 7th Division's Red Cross Donut Dollies have promised that whoever receives the 777th donut on that day will receive a special prize from them.

The BAYONET newspaper is sponsoring a contest of its own. All you have to do to get your name and picture in the paper is count up the number of times that the number "7" appears, either as a numeral or spelled out. The contest is open to all military personnel from the 7th Division, with the exception of Information Office personnel. The deadline for the contest is September 30.

In addition, commanders have been asked to implement other means of celebrating 7777 day, so there may be a few surprises in store for you, the members of the 7th Inf. Div.

The CBR officer successfully destroyed a napalm-doused, wooden cross 40 meters away. The flamethrower has a range of 30-40 meters and burns for nine seconds.

Bayo Badges Presented

CAMP HOVEY — Bayonet Badges and Armed Forces Expeditionary Medals were awarded to 839 men of the Bayonet Division at Badger Field 7th Inf. Div., September 14.

Maj. Gen. O.A. Leahy, commanding general, 7th Inf. Div., awarded the decorations to men of Hqs. & Hqs. Co., 2nd Bde., and 1st Bn., 32nd Inf., who have recently returned from serving their tour of duty at the DMZ.

The Bayonet Badge is a 7th Inf. Div. award for men who have participated in patrol missions on the DMZ. There have been only two other units in the 7th Inf. Div. to receive the Bayonet Badge.

Gen. Leahy made token presentations to Col. William R. Guthrie, commanding officer 2nd Bde.; Lt. Col. Phillip P. Walpole, commanding officer, 1st Bn., 32nd Inf.; Sgt. Maj. Lorasla D. Bowen, 2nd Bde.; and Sgt. Maj. David T. Cobb, 1st Bn., 32nd Inf.

Gen. Leahy commended the men for performing hazardous duty at the DMZ in an outstanding fashion.

Editorial

It's Up To You

What harm is there if I don't vote? a serviceman might ask. There's a great deal of harm to the country when any citizen fails to exercise this right. History cites case after case in which a person's individual liberties have been lost because the majority of the citizens ignored their balloting responsibilities.

In the past many servicemen found it very difficult to vote because they could not reach the appropriate voting place in their state of legal residence on Election Day. This was prevalent during World War II, when less than 1 percent of the 5 million servicemen voted in the 1942 election.

In 1955 however, the Federal Voting Assistance Act, was passed which allows men in all branches of the Armed Forces to exercise their legal right of voting. This is done by absentee ballots. Absentee balloting helps the soldier cast his ballot no matter where he is stationed.

There is one prerequisite before casting one's ballot however. This prerequisite is desire. The desire to know what is going on in your state, and federal elections. It is of the utmost importance to make it your business to know the voting policies and procedures in your home state. Just because you are overseas, and a long way from your home doesn't give you the right to neglect this responsibility of voting.

Think of it this way: If only one-half of the eligible voters in the Armed Forces voted, and only one-half civilians in the United States voted, the U.S. government would not be representative of the majority. Therefore if only the minority goes to the polls, minority opinion would determine the election's outcome and the government would be unrepresentative.

This has been the case before. Thank God not in the United States, but in other parts of the world. The Communist Party in Russia, Mussolini and his Fascists, and Hitler all were products of the lack of voter participation. Remember what happened to those countries and apply it to what could happen anywhere. In each one of these cases a minority prevented the majority from freedom.

President Abraham Lincoln once said that "Ballots are the rightful successors of bullets."

A citizen who fails to use his vote is like a combat soldier who fails to use his weapon. As citizens in uniform, military personnel should shoulder, with civilians, the democratic institutions with their votes as they are prepared to do by force of arms.

To be blunt about the whole thing.

PX System Under Reorganization

SEOUL—Many have no doubt, noticed the low level of stocks in the PX's in the 7th Division. The main reason for this was the reorganization and mistakes made earlier in the year by the PX system.

In addition to this the stocks that were left on the shelf were being quickly grabbed up as the panic-buy set in.

As a newly established Exchange Region, the PX's in Korea have had a hectic two months of existence. Under the old organization goods were purchased by JAKOR 4 to 6 months ahead of time. Unfortunately efforts to eliminate excess stock and a lack of information to enable forecasting the number

of troops which would be in Korea, caused underestimates in the quantity of merchandise required.

Since this split with Japan, the new PX system has developed an Inventory Management and Data Processing System which is helping them combat the immediate problem and preclude its recurrence. Between June and July this year, our Inventory Management Branch initiated 1,165 emergency purchase orders 25 per cent of which were requested to be airlifted.

In the future the new Korea PX system will be able to personally review all Exchange Branch requirements and determine wants and needs, thus making a much closer ordering

estimate possible. However, remember an ordering cycle normally takes 120 days from the time the purchase order is processed until the merchandise arrives in Korea, therefore the real effectiveness of this new system won't be fully realized until October when the first supplies ordered by the system are due. Until that time, the emergency orders will alleviate some of the "out-of-stock" situation and an "in-stock" improvement should be noted at local Exchanges within the next few weeks.

There are now more than adequate stocks in Inchon. What the PX system is now trying to accomplish is to get as much of these stocks to the Exchanges throughout Korea as possible.

Camp Kaiser Tunnel Has Misleading Name

CAMP KAISER—Every 7th Inf. Div. soldier traveling from Camp Beavers to Camp Kaiser along Route 33 passes through a mountain tunnel carved from sheer rock. This tunnel is referred to by the men at Camp Kaiser as the "Chinese Tunnel." "American soldiers always get names mixed up, even with this tunnel," says Sgt. 1. C. Henry Daniels, NCOIC of the Security detachment at Camp Kaiser, "This tunnel was not constructed by the Chinese, but by the Japanese in 1930."

Thirty-eight years ago, the Japanese imported their own stonecutters to carve out an opening 25 feet high. Chiseling at a slow pace, the stone-cutters finally broke through the other side of the mountain 130 feet and one year later.

A quick journey toward Camp Kaiser along Route 33 is all that one needs to see the importance of the tunnel.

A few feet from the opening of the tunnel, the mountain plummets about 200 feet to a shallow mountain stream.

During the monsoon season, this quiet shallow stream becomes a swirling river which prohibits all forms of vehicular transportation.

The Japanese were forced into either constructing a road over the steep mountain range, which is characteristic of this area, or going through the mountain. The Japanese chose the latter as being the most expedient.

The tunnel when completed, was too short to be ventilated properly, and too isolated to be lighted adequately.

Since the tunnel's completion in 1931, it has been used by a host of armies inside Korea. After the Japanese were expelled in 1945, the South Koreans used it.

The North Koreans used it during the first phase of the Korean War and the United Nations Armed Forces liberated the tunnel during the second phase. The Chinese Communists sent men and supplies along the route in the big counter attack that followed.

Finally after the 1953 truce, the tunnel was once again used by the South Koreans.

Observing the inside of the tunnel, one can see the individual marks of the chisel made 38 years ago. With water from the roof of the tunnel, it has the atmosphere of a dungeon. No one knows for sure how many men died while constructing this tunnel.

Call it what you will; Chinese tunnel, Japanese tunnel or just plain tunnel, there has been a lot of chiseling.

Pusan Railroad Still Busy Place

ALONG THE PUSAN TO PARIS RAILROAD, AT MUNSAN—Thirty years ago a daring, determined traveler could have boarded a train in Pusan, Korea and with luck arrived in Paris, France, in three weeks.

The rearrangement of international borders following World War II made the trip more difficult, but it wasn't until the unprovoked invasion of South Korea that the trip became impossible.

Today, the rail tracks end at Munsan, some 30 miles north of Seoul. Beyond the passenger terminal, the tracks run a few hundred yards to the freight facility that services the U.S. 2nd Infantry Division.

Beyond that point, the rail line, started by an American and constructed by the Japanese, ends. Not all the traces have disappeared, however.

A mile north of the freight yard the rail-bed used to curve gently around a hillside and continue several hundred feet through a tunnel. Today, that part of line is a narrow flat track, where squatter farmers grow rice, corn, peppers, sweet potatoes, cabbage, peas, peanuts, and even mushrooms.

The tunnel was sealed by a landslide at the north end, and in 1964 a family from Seoul, displaced by floods which wiped out their home near the Han River, enclosed the south end with a wall to take advantage of the cold storage possibilities inside.

They built a couple of shacks in front and put a pole fence

in front of that. The curve which locomotives used to charge around at 40 mph is now a patch of corn and beans.

North of the tunnel tracks previously rode on twin railbeds elevated above the marshy rice paddies. Now one bed serves as a graded auto road, while the other is cultivated.

At a point where there was a switching junction, an enterprising business man has set up a car wash and advertises steam cleaning in big crude letters.

Further down the track were two small bridges across streams. The western side bridges are gone. The eastern have been rebuilt and handle light road traffic.

At the mighty Imjin River, the twin spans of track once crossed on identical bridges. Now only one remains, and it handles one-way truck traffic. Alongside, the scarred pilings of the other jut out of the swift current. Hundreds of pigeons congregate atop them. Water snakes take advantage of their shelter from the current to swim the river.

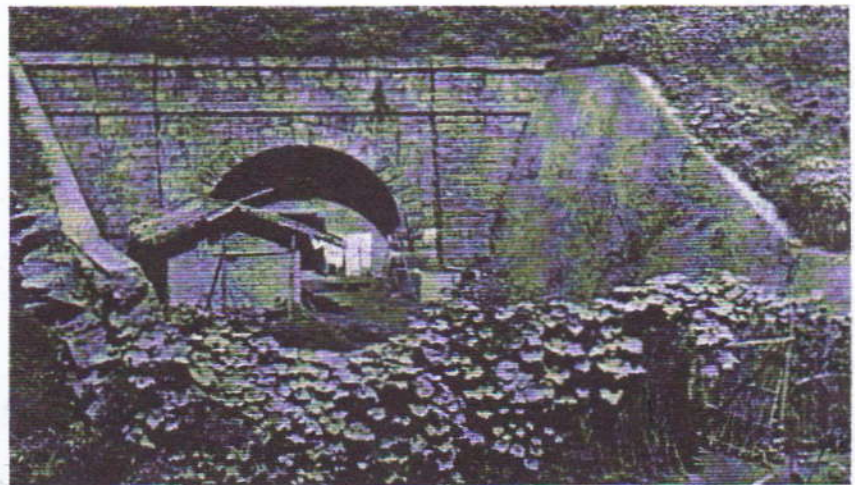

Where trains used to rumble through the hill, this tunnel has been walled up and is now used for cold storage. A brick dwelling and a small garden now occupy what used to be trackbeds along the Pusan to Paris railroad. The rails were lifted for their scrap metal value years ago, after the Korean War cut off all service north of Munsan.

North of the Imjin no trace remains until the Demilitarized Zone.

In the zone, the tracks run west for a few miles. Here no scavengers have pulled up the track for its scrap iron. Nature has not been idle, however. Trees grow between the ties and weeds, wild rice, and brush have grown up, making the rails hard to find.

As the tracks run through a natural depression dubbed

"Ambush Alley," the concrete sides of the cut are lined with moss and seedlings have grown.

Then there is the locomotive. It is huge and completely rusted. Hundreds of bullet holes of a dozen calibres pit the hulk. It was headed east with a trainload of North Korean soldiers bound for the front when suddenly it found that the front had moved.

An air strike and a company of the U.S. 24th Infantry Division

took the steam out. Today it sits like a giant flower pot with green plants growing from it.

Nearby, a boxcar, derailed in the same action, is surrounded by a field of wild peas. A tree grows through the undercarriage.

North of the wrecked locomotive is the Military Demarcation Line. Only the communists know what happens to the track from there.
