### **Saluting Arlington Cemetery facts**

The property belonged to George Washington Parke Custis, who was both the adopted grandson of our first president and the father-in-law of Robert E. Lee. His daughter Mary Custis Lee inherited the land, but when the Civil War broke out in 1861, the Lees abandoned their Arlington estate. The U.S. Army seized it to help defend the capital, then buried the North's war dead there as a further insult to the Lee family.

"Get them yourself," the man replied. "You're in the Army now!"

### Court awards \$2.3 billion to U.S. spy ship crew held hostage in 1968

A U.S. federal court has ordered North Korea to pay \$2.3 billion in damages to the crew and family of the spy ship USS Pueblo who were tortured and mistreated for 11 months in 1968 after being captured by the North Korean navy. The Washington federal court said that the surviving members of the crew and families of those now dead are owed compensatory damages for confinement and suffering of \$1.15 billion and doubled that for punitive damages against Pyongyang.

It said many of the 83-strong crew, one of whom was killed by the North Koreans when they seized the Pueblo on January 23, 1968, were mentally and physically abused during their captivity.

In addition, wrote Alan Balaran, the government-appointed "special master" in the case to decide how damages were to be apportioned, most suffered long-lasting after-effects, both psychological and physical.

"As a result of the barbarity inflicted by the North Koreans, almost all required medical and/or psychiatric intervention," Balaran wrote.

"Many have undergone invasive surgical procedures to ameliorate the physical damage resulting from the relentless torture they underwent as prisoners," he wrote. "Several have attempted to numb their pain through alcohol and drugs, and most have seen their domestic and/or professional lives deteriorate. A few have contemplated suicide."

The North Koreans released propaganda photos and videos that showed a number of the captured sailors raising the middle finger to the camera as a sign of protest. They told their captors, who were unfamiliar with the gesture, that it was a "Hawaiian good luck sign."

Those early burials were racially integrated. But once Arlington became a national cemetery in 1864, all subsequent graves were segregated by race until Harry Truman desegregated the military in 1948.

The lawsuit was only brought in 2018 after the U.S. Justice Department ruled that, despite a law giving foreign government's broad immunity from suits in U.S. courts, they could be sued if the government had been designated a state sponsor of international terrorism.

In late 2017 the Trump administration officially declared North Korea a sponsor of terror.

The Pueblo was on its first voyage as a U.S. Navy spy ship, under the guise of an environmental research vessel.

Pyongyang says it was in North Korean waters when it was captured, which Washington denied.

But it came as the U.S. was mired in a war in Vietnam and just as North Korean operators entered South Korea and tried to assassinate president Park Chung-hee.

That effort failed, but a number of South Koreans were killed and the seizure of the Pueblo crew complicated Seoul's desire to respond militarily.

The crew was freed after nearly a year of negotiations in December 1968, but Pyongyang held onto the Pueblo, making it into a museum.

The U.S. Navy still maintains it on its roster of active ships.

The court, in a final ruling on Wednesday, awarded damages of \$22 million to \$48 million to each of the 49 surviving crew members, and smaller sums to about 100 family members.

North Korea was not represented in the case, and it was not clear whether and how the victims expected to recover damages.

### **Saluting Arlington Cemetery facts**

All Presidents can be buried at Arlington, yet only two are: William Taft and John F. Kennedy. Abraham Lincoln's son Robert is also at Arlington, despite his wishes to be buried beside his father in Springfield, Illinois. (Roberts wife arranged his services and chose Arlington.)

A good time to let it all hang out, (WE NEED NEW MEMBERS) as you know our supply of members we need has dried up.


I was a member of the 7<sup>th</sup> Infantry Division Association for many years, which now has called it quits due to membership decline.

### **Saluting Arlington Cemetery facts**

Even though the cemetery conducts up to 30 funerals each day, Arlington isn't keeping up with demand. Officials give priority to active service members over veterans and to military members over family members. The wait list is so long that months can pass between a death and the funeral.

### Where to Request Military Service Records

### Request Your Military Service Records Online, by Mail, or by Fax

https://www.archives.gov/veterans/military-service-records/Request Your Military Service Records Online, by Mail, or by Fax (Includes DD 214/Separation Documents, Personnel Records, Replacement **Medals**, and/or Medical Records).

Are there alternate sources to obtain military service records?

Yes, modern service records, generally for veterans who separated after Calendar Year 2002, are available in electronic format. NPRC has deployed new digital delivery functionality to enable some of these requests to be serviced by its staff from remote locations. To be eligible for this service it is imperative that requesters submit a request using our online application, eVetRecs, and provide an email address with their request. If you provide an email address and your request involves records available in electronic format, our staff will obtain the records and provide you with credentials that will enable you to download the requested records from a secure server. This service is available only when (1) the responsive records are available in digital format, and (2) requesters provide an email address with their request.

In many instances, records that are available in electronic formats may also be accessed directly by veterans, without involvement from NPRC, through the Department of Veterans Affairs (VA) eBenefits application at <a href="https://www.ebenefits.va.gov/ebenefits/homepage">https://www.ebenefits.va.gov/ebenefits/homepage</a> or the Department of Defense milConnect application at <a href="https://milconnect.dmdc.osd.mil/milconnect/">https://milconnect.dmdc.osd.mil/milconnect/</a>. Modern military medical records may be accessed through the VA's Blue Button application at <a href="https://www.va.gov/health-care/get-medical-records/">https://www.va.gov/health-care/get-medical-records/</a>. # Temporary Reduction in Onsite Operations at the National Personnel Records Center (NPRC) in St. Louis

Due to the resurgence of COVID-19 infection in the local communities, the NPRC is operating at a reduced capacity. As of August 2, 2021, the NPRC has reduced its on-site staffing to 10 percent of the workforce. While we remain in this state, we will continue to service emergency requests associated with medical treatments, burials, and homeless veterans trying to gain admittance to a homeless shelter. Please refrain from submitting non-emergency requests such as replacement medals, administrative corrections, or records research until we return to pre-COVID staffing levels.

### KOREAN WAR VETERANS MEMORIAL WALL OF REMEMBRANCE

In October 2016, President Barack Obama signed into law legislation authorizing the establishment of a Wall of Remembrance to be incorporated into the existing Korean War Veterans Memorial that currently resides on the National Mall in Washington, D.C. The Wall of Remembrance will become the permanent home to the names of the 36,595 American servicemen and 7,174 Korean Augmentation to the United States Army (KATUSA) who gave their lives defending the people of South Korea.

In 1953, the Korean Armistice Agreement ended more than 3 years of brutal fighting against communist expansionism and tyranny on the Korean Peninsula. On National Korean War Veterans Armistice Day, we honor the brave patriots who secured freedom and democracy in the Republic of Korea, and we pay tribute to the more than 23,600 Americans who were killed in action and the more than 103,000 who were wounded in that conflict.

The dedication stone at the Korean War Veterans Memorial in Washington, D.C., bears the inscription: "Our Nation honors her sons and daughters who answered the call to defend a country they never knew and a people they never met." The memorial includes an honor roll of Americans killed in action and those missing in action, and its unique design features statues of a patrol crossing a Korean rice paddy. These figures represent the heroes of our Armed Forces who valiantly served in the Land of the Morning Calm and fought on battlefields such as Inchon, the Pusan Perimeter, and the Chosin Reservoir. Today, this hauntingly beautiful memorial stands as an enduring reminder of what it costs to defend and preserve the democratic principles, we hold dear.

Our ironclad alliance with the Republic of Korea was cemented when the first American troops arrived on its soil to fight for liberty and human dignity. More than six decades after the ceasefire on the Korean Peninsula, the Republic of Korea is flourishing as a prosperous and peace-loving democracy. Since the signing of the armistice at Panmunjom, the United States has worked with the Republic of Korea to preserve peace through strength. Our military, together with our allies, stands vigilant, strong, and "ready to fight tonight" on the ground, in the air, and at sea. The phrase "katchi kapshida" — "we go together" — is on the lips of every service member in Korea, representing generations of Koreans and Americans united by shared sacrifice and a willingness to uphold the cause of freedom no matter the cost.

Today, we honor our Korean War veterans for service rendered to both the United States and the Republic of Korea, and we remember their families who supported them throughout. Sometimes called "The Forgotten War," we will always remember the immeasurable cost incurred by those who fought on the Korean Peninsula. The bravery, tenacity, and selflessness of our veterans liberated the oppressed, brought peace and prosperity to a freedom-loving people, and helped forge our unshakable bonds with the Republic of Korea.

### **AMBUSH ON THE DMZ**

ALONG THE DMZ, Korea — Observers at the scene of Sunday night's bold ambush by Communist North Koreans who machine-gunned and killed four United Nations Command soldiers reached one conclusion: "I don't see how anybody survived this."



About 20 bullet holes could be seen in the shattered front windshield of the truck. Both headlights were blasted out. Three of the tires were punctured and at least 40 rounds had ripped through the truck's rear canvas cover. Two UNC troops survived the attack but were wounded.

A pool of dried blood, a severed wristwatch, glass fragments and discarded bandage wrappers were scattered around the ground near the truck.

A U.S. Army spokesman said parts of a Soviet fragmentation grenade were found. Lt. Col. M. G. Engle, chief of the UNC Joint Observation Team, found several empty North Korean ammunition clips and numerous spent rounds of Soviet-made 7.62-mm bullets near the ambush scene.

Engle had arrived here to meet with a North Korean delegation at 6 a.m. Monday to investigate the ambush, but the Communists failed to show up. They had been asked by Rear Adm. J. V. Smith, UNC senior member of the Military Armistice Commission, to participate in a Joint Observer Team (JOT) investigation.

Meanwhile, Lt. Col. Herman A. Praeger, commander of the 8th U.S. Army Support Command Advance Camp three miles south of Panmunjom, described the machine-gun fire which cut down the relief guards as "deadly accurate and delivered from close range."

Praeger, one of the first U.S. officials to arrive at the scene, shortly after 11 p.m. Sunday, said about 200 rounds of machine-gun fire came from both sides of the dirt road.

The three-quarter-ton truck, lights on and flying a white flag in accordance with armistice rules, carried three men in the cab and three others in the back under cover of the canvas top, according to Praeger.

The UNC guards were carrying .45-cal. pistols, but it was not known whether they returned any shots, Praeger said.

The dead and injured were taken by helicopter to the 121st Evac. Hospital in ASCOM after the ambush.

The truck and guards were from the support element at the Advance Camp, not from the 2nd Inf. Div. as previously reported.

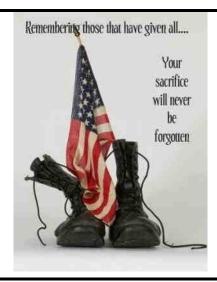
